What is the WOTC?

The Work Opportunity Tax Credit Program provides businesses with substantial tax savings for each qualified employee hired from the targeted groups.

Commonly known as WOTC, the program provides a credit against an employer's federal tax liabilities of up to \$9,600 per employee. The amount of the actual credit depends on several factors, including target group, hours worked and wages earned in the employer's business.

On December 18, 2015, President Obama signed into law the Protecting Americans from Tax Hikes Act, which, in part, authorizes an extension of the WOTC Program for new hires from December 31, 2014 to December 31, 2019.

What are the target groups?

- TANF Recipients
 - Ex-felons
 - Rural Renewal County Residents
 - Empowerment Zone Residents*
 - Vocational Rehabilitation Referrals
 - Summer Youth
 - Supplemental Nutrition Assistance Program (SNAP) Recipients
 - Supplemental Security Income (SSI) Recipients
 - Long-term TANF Recipients
 - Long-term Unemployment Recipients
- * The Empowerment Zone designations expired on December 31, 2017. You may continue to apply for this target group, but processing will be held.

How much tax credit is available by target group?

Up to \$1,200

- Summer Youth

Up to \$2,400

- Long Term Unemployment Recipients
- SNAP Recipients
- Veterans Receiving SNAP Benefits
- Veterans Unemployed at Least 4 Weeks Prior to Date of Hire
- TANF Recipients
- Ex-Felons
- Rural Renewal County Residents
- Empowerment Zone Residents
- Vocational Rehabilitation Referrals
- SSI Recipients

Up to \$4,800

- Veterans with a Service-Connected Disability Hired within One Year of Release from Active Duty

Up to \$5,600

- Veterans Unemployed for 6 Months Prior to Date of Hire

Up to \$9,000

- Long Term TANF Recipients (Receiving Benefits for at Least 18 Consecutive Months)

Up to \$9,600

- Veterans with a Service-Connected Disability Unemployed for at Least 6 Months Prior to Date of Hire

To apply for WOTC

Businesses must apply for, and receive certification from the Mississippi Department of Employment Security (MDES) that the newly hired employee is a member of at least one of the WOTC target groups before the business can claim the WOTC credit on its federal income tax return. Forms are available on our website. See the bottom of this page for the web address.

TO APPLY FOR THE CERTIFICATION, BUSINESSES SHOULD FOLLOW THREE STEPS:

- 1 Complete page 1 of IRS Form 8850, Pre-screening Notice and Certification Request for the Work Opportunity Credit, by the date of the job offer, and page 2 of IRS Form 8850 after the individual is hired;**
- 2 Complete one of the following U. S. Department of Labor forms, as appropriate:**
 - ETA Form 9061, Individual Characteristics Form, if the new hire has not been given a Conditional Certification, ETA Form 9062, or
 - ETA Form 9062, Conditional Certification Form, if provided to the job candidate by a Participating Agency (such as Vocational Rehabilitation), an Employment Network, or the State Workforce Agency (MDES).
- 3 File the signed and dated IRS and ETA forms with MDES not later than 28-calendar days after the new hire's employment starting date.**
